Sanbase is an interior fit-out solutions provider focusing on providing services to clients whose offices and predominately situated in Grade A offices in Hong Kong. The main categories of services include: (i) bare shell fit-out; (ii) restacking; (iii) reinstatement; (iv) maintenance and (v) churn work. According to the Industry Report, Sanbase is the largest fit-out solutions provider for Grade A offices in Hong Kong in terms of market share in 2016. During the Track Record Period, the Group worked on 230 projects for a total of 107 clients. Revenue for the two years ended March 31, 2016 and 2017 and the three months ended June 30, 2016 and 2017 were HK\$231.1 million, HK\$280.7 million, HK\$42.2 million and HK\$72.8 million, respectively, representing a growth of approximately 21.5% from the year ended March 31, 2016 to the year ended March 31, 2017 and a growth of 72.5% from the three months ended June 30, 2016 to the three months ended June 30, 2017.
