Sanbase was Awarded a HK\$26m Restacking and Reinstatement Contract

(Hong Kong – 21 February 2018) The largest interior fit-out solutions provider for Grade A offices in Hong Kong – **Sanbase Corporation Limited** ("Sanbase" or "Company", and its subsidiaries "Group", stock code: 8501) is pleased to announce that the Group was awarded a restacking and reinstatement project (the "Project") for a multinational financial services firm, at its premises located at Manulife Financial Centre in Kwun Tong and One and Two Exchange Square in Central (collectively, the "Premises"), for a total contract sum of approximately HK\$26 million. The Project is expected to be completed by the end of July 2018.

Sanbase will act as the main contractor of the Project, whose roles entail the overall project management, coordination, and implementation of restacking and reinstatement works to be provided by subcontractors to the Premises. In connection with the Project, the Group agreed to provide (i) a surety bond in the sum of approximately HK\$2.9 million; and (ii) liquidated and ascertained damages should there be any delay in the completion of the Project. The Group intends to use part of its proceeds raised from the global offering to finance the startup cost and the surety bond of the Project.

Mr. Wong Sai Chuen, Chairman of Sanbase Corporation Limited stated, "We are delighted to be recognized by the market and awarded a project of such magnitude, which is a tribute to Sanbase's dedicated effort in providing quality services, as well as maintaining good relationship with its clients amid ever-changing market needs. We remain positive regarding the prospect of the interior fit-out market in Hong Kong, and in the future, we will continue to expand our operations scale and network, while keeping a keen eye on further business opportunities, in order to deliver greater returns to our shareholders."
